- NC Emergency Vehicle Driver certification (within 90 days of employment)
 - NC Class B Driver's License (within 90 days of employment)

Reference materials that you should be familiar with are the *IFSTA 5th Edition Essentials of Fire Fighting*. The test day information is as follows:

PHASE I

1. 50 question written test. You will have 1.5 hours to complete. (50 Pts)
2. The Physical skills assessment will comprise of firefighter I and II skills. (50 Pts.)

After this phase, we will look at the scores and invite the top candidates back for the phase II part of the hiring process

PHASE II

1. An initial interview.
2. Passing of a physical fitness exam
3. Passing of a background investigation

Physical Skills Testing Procedure

The following will be areas that will be addressed during the Physical Skill Testing. Remember that you will need to do the physical test after your written test. If you would like to change clothes, we will have a changing area available. If you have your own turnout gear and would like to wear it that will be fine, as long as it meets NFPA and Summerfield Fire District standards. Tennis shoes will be the acceptable footwear for the course. Summerfield Fire District will provide the air pack for you to wear (you will not be breathing air). At any time that the candidate stops for a period of 15 seconds at any of the stations, they will move on to the next section and receive points that they had completed. You will be able to watch a run through of the skills the morning of the testing.

1. Ladder Climb
2. Hose Roll
3. Set up a water supply from an engine to place a 2 ½ into operation
4. Pull a charged hose line
5. Roof ladder placement
6. 5 knots
7. Ventilation strike
8. Placing ventilation fan into operation
9. Hose hoist
10. Dummy Drag
